Repowering of the existing Rogers Hill wind turbine with a larger wind turbine


The Parish Council took representation from numerous members of the public who raised concerns on matters including – size, sound, quality of application, environmental impact,

Scale and dominance

Drainage, sewage and flood risk



Noise, dust, fumes etc
Impact on character or appearance of area
Effect on listed buildings and conservation areas
Effect on trees and wildlife/nature conservation especially birds, bats and raptors

Members certified that the audit was complete subject to any feedback from the external auditor.

11. Parish notices

It was confirmed that the dog waste bins at the HiP had been emptied.

It was noted that the track at the reservoir now had a planning application regarding it.

It was confirmed that the verge on the left-hand side of the exit to Roke Road was not part of the Parish Council grass cutting contract.

It was mentioned that although this was very community minded, the responsibility for visibility at road junctions lie with Dorset Council.

A question was raised about overgrown rights of way.

It was confirmed that the best course of action was to report this via the Dorset Council website.

This led to a conversation on the overgrown stream at March Bridge.

It was stated that the responsibility was with the riparian owner, but also clearance was limited due to the water vole population.

To conclude, everybody was brought up to date with matters at the Household Recycling Centres. A change in policy meant that only Dorchester and Shaftsbury would have an online booking system introduced.
